MESSAGE FROM THE CHAIR



The year behind us was a turbulent one which produced a great deal of work for the Commission. Many of the issues will flow over to the year ahead.

2013 continued to be a year of uncertainty about funding, like 2012 and the year before. However, the election held on 7 September 2013, helped the Commission in coming to a more confident and firmer

decision about what funds were available and how they might be distributed.

The Commission continues to be grateful for the relationship that exists between itself and the Queensland State Government and Opposition, as well as the interactions established between the Commission and the Australian Government and Opposition. I particularly thank John-Paul Langbroek, the Queensland Minister responsible for matters related to Catholic schooling. He has always been willing to consider the Commission's position, and listen attentively to its needs.

The Commission has also been helped enormously by the National Catholic Education Commission (NCEC), which is now operating within a new structure, following its formal review. The Commission is confident that the new NCEC will continue the outstanding work of the outgoing NCEC under the leadership of its past Chair, Therese Temby, and wishes its new Chair, Greg Crafter, the very best for the years ahead.

There are a number of major concerns that the Commission has grappled with during 2013, apart from level of funding. It is particularly conscious, for example, that the present political climate must appreciate the significant growth occurring in new schools, which has been well signalled by the Executive Director in his Report. Another important issue is the Commission's growing anxiety that excessive regulation in the sector has the potential to stifle initiative and the Commission's established effectiveness for offering quality Catholic education throughout its schools.

Catholic schooling has a tremendous tradition to uphold. It offers caring, and concerned, quality education to all those enrolled in our schools. It is a much respected tradition, and the Commission will do everything it can to maintain it, and to continue to argue the case for quality education in the future.

I am deeply grateful, as I have expressed in past Reports, for the support of Archbishop Coleridge and the Catholic Bishops, the support and cooperation of the Religious Institutes, the help of the Queensland Parents and Friends Federation, the marvellous assistance given by our teachers and principals, and for the outstanding work of the Executive Director of the Commission, Mike Byrne, who is very ably supported by a highly efficient Secretariat. My thanks also to Lee-Anne Perry, Deputy Chair of the Commission, for standing in for me when I have not been able to be there.

I welcome especially the new members of the Commission in 2013, Pam Betts and Br Neville Solomon, and thank the outgoing member, Tracey Sanders for her commitment and contribution to the Commission.

Members of the Commission deserve great praise for their valued assistance throughout the year. The work of the Commission, and that of the Diocesan Directors of Catholic Education, in particular, would be impossible without Members' strong personal commitment to all that the Commission stands for and their willingness to work selflessly on its behalf.

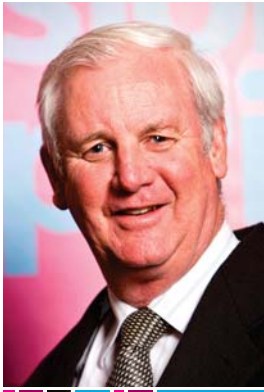

REPORT FROM THE EXECUTIVE DIRECTOR



As the year commenced, around 141,000 students and 17,000 teachers and staff returned to 296 Catholic primary, secondary and P-12 schools across Queensland, with an enrolment increase of 2.3%. Enrolments in Catholic schools represent about 18.5% of all Queensland students and almost 60% of students in non-government schools.

This year, two new Edmund Rice Australia Flexible Learning Centres opened at Hemmant and Inala, and students were welcomed to new schools at Good Shepherd Catholic Primary School, Springfield Lakes and St Benedict's College, Mango Hill. In addition, 13 new kindergarten services were opened on Catholic school sites, bringing the total number to 18, with student enrolments at around 565.

QCEC welcomed in the New Year with a function for key partners in education in Queensland. This was an opportunity to strengthen partnerships and professional relationships as the new school year got under way. We are privileged to enjoy a strong spirit of collegiality across government, Catholic and independent education sectors in Queensland and events like this are an opportunity to build on these relationships.

Two new Commission members, Pam Betts, Executive Director, Catholic Education Archdiocese of Brisbane and Br Neville Solomon, Representative of Catholic Religious Australia (Queensland) attended their first Commission meeting in February.

In March, the Commission joined with Catholic communities around the world to celebrate the announcement of Cardinal Jorge Mario Bergoglio of Argentina, as the 266th Pope. His Holiness, Pope Francis continues to inspire us with his humility, his concern for the poor and his less formal approach to the papacy.

The Federal election, the Australian government review of school funding and the State budget were among the major agenda items that made for a busy and challenging year.

In the lead-up to the Federal election, the National Catholic Education Commission (NCEC) identified six key issues requiring a positive commitment from the next Australian Government for sustainable Catholic education in Australia. The Commission, together with the Queensland Parents and Friends Federation, developed a suite of resources to support the campaign process and keep school communities informed. In responding to the six key issues, the incoming Coalition Government indicated a strong recognition of the contribution of Catholic education and support for its ethos which is vitally important to inform policy decisions.

Late in the year, the Commission welcomed the Australian Government's commitment to certainty around both the quantum of funding and the funding model determining the funding available for all Australian schools, for the next four years. The Commission will continue to work closely with the government through the scheduled reviews to ensure the funding model is operating effectively.

At State level, the Commission worked with Minister John-Paul Langbroek and the Newman government on a broad range of issues and initiatives. The establishment of the Schools Planning Commission was a good example of successful cross-sectoral collaboration facilitated by the State Government and will help streamline and coordinate the processes for the planning, establishment and expansion of government and non-government schools across Queensland.





The Commission also welcomed the following State Government initiatives:

- approval of \$52.1m in Round 2 of the Queensland State Government's *Flying Start Capital Assistance Scheme* to develop facilities to accommodate around 11,000 Year 7 students in 93 Catholic secondary colleges across the state from 2015. Catholic education authorities in Queensland have also planned a range of professional learning opportunities to build the capacity of all teachers in areas associated with the movement of Year 7 to secondary in 2015.
- an additional \$98million for the non-government schooling sector to be invested over four years from 2015 as part of the *Great Teachers = Great Results* action plan. This additional funding will assist Catholic schools to further support teachers to develop their skills and consider other ways to improve teacher quality and performance.
- an independent review of Queensland's senior assessment and tertiary entrance processes to be completed by mid-2014. The review will examine current practices and identify areas of change to best support contemporary senior assessment and tertiary entrance systems.

In May, the Commission travelled to Cairns for its monthly meeting and visited 11 Catholic schools across the Cairns Diocese, including Our Lady of the Sacred Heart School, Thursday Island. These annual visits to schools provide the opportunity for Commission members to experience the special character of our Catholic schools and stay in touch with what is happening 'on the ground' in these Catholic school communities.

Catholic Education Week was celebrated across Queensland from 21-27 July with a wide range of activities and events. This year's Ambassador, Anthony Ryan, visited all five dioceses, delivering his powerful message which brought to life this year's theme *Making a Difference... Inspired by Jesus*.

I am most grateful to all who have supported and contributed to the work of the Commission during 2013, especially Archbishop Mark Coleridge and the Bishops of Queensland; Leaders of Religious Institutes and PJPs with schools in Queensland; Diocesan Directors of Catholic education; Hon Greg Crafter AO, Chair and members of the National Catholic Education Commission; Hon Campbell Newman, Premier of Queensland; the Federal Minister for Education, Hon Christopher Pyne MP; the State Minister for Education, Training and Employment, Hon John-Paul Langbroek; Director-General Department of Education, Training and Employment, Dr Jim Watterston and the Executive Director, Independent Schools Queensland, Mr David Robertson.

In particular, I acknowledge Bishop Brian Heenan, recently retired Bishop of Rockhampton and thank him for his significant contribution to the ministry of Catholic education.

Finally, I am once again grateful to Emeritus Professor Peter Sheehan AO, Chair and members of the Commission, together with the QCEC Secretariat staff and all those who serve on our many committees, working parties and taskforces. Your commitment to working together to provide quality education for all Queensland students is greatly appreciated.

ABOUT THE COMMISSION

The Queensland Catholic Education Commission is a 16 member body with certain state-wide responsibilities in respect of the Catholic schools administered by five diocesan (regional) education authorities and 15 Religious Institutes or other incorporated bodies.

The role of the Commission is essentially strategic and has as its principal goal the greater co-ordination and advancement of Catholic education in Queensland. The Commission has an independent chairperson and includes the Executive Director, Bishops' representative, Directors of each diocesan employing authority and representatives of Catholic Religious Australia (Queensland), Federation of Parents and Friends and Diocesan Catholic Education Councils and Boards.

To support its work, the Commission has established a number of committees and subcommittees to draw upon the wisdom and expertise within Catholic education across Queensland. The operations of the Commission are carried out by a Secretariat staff based at the Catholic Centre in Edward Street, Brisbane.



KEY FUNCTIONS

The Bishops of Queensland and Leaders of Religious Institutes Queensland have delegated a number of functions to QCEC including:

- negotiating and distributing government funding to Catholic schools
- advocating and promoting the position of Catholic education and liaising with State and Australian Governments and various peak bodies, including the Federation of Parents and Friends, across a range of educational issues
- communicating and responding both internally and through the media to issues relevant to Catholic education state-wide, and nationally in co-operation with the National Catholic Education Commission (NCEC)
- facilitating collaboration between Catholic education employing authorities for industrial relations matters
- facilitating collaboration between Catholic school authorities in areas such as curriculum, information and communication technologies, religious education outside Catholic schools, education for ministry and social justice matters
- researching, collecting and managing relevant statistical data.

2. Community engagement, representation and advocacy

2.1 To provide strategic leadership and advocacy to enhance accessibility to Catholic schooling

QCEC proactively promoted the need for adequate resourcing to provide equitable access to the curriculum for students with disability in Catholic schools.

2.2 To facilitate ongoing dialogue with delegating authorities and monitor and respond to the emergence of future governing structures of their schools

Collaborate with Catholic Religious Australia Queensland (CRAQld) and develop processes at state-wide level to enhance the Commission's interactions with all public juridic persons (PJPs) who are not dioceses operating schools in Queensland. (These PJPs include religious institutes who are PJPs by virtue of Canon Law and other PJPs erected by competent Canonical authority).

- Liaison with the Executive Officer CRAQld Education Committee formed the most effective basis of communication between QCEC and public juridic persons (PJPs) who are not dioceses.
- QCEC received an official Delegation of Authority dated 7 May 2013 from the Trustees of Edmund Rice Education Australia to replace the previous delegation from the Trustees of the Christian Brothers (Queensland).

2.3 To identify and seek opportunities to promote and enhance the mission of Catholic schooling in the context of emerging national and state agendas

- i) Determine key principles to guide proactive responses to future government initiatives.
- ii) Monitor developments related to the Australian Curriculum from a Religious Education/Catholic perspective.
- iii) Monitor developments related to emerging legislation, regulation and government inquiries.
- iv) Facilitate collaboration among Catholic school authorities in relation to their engagement with the *Royal Commission into Institutional Responses to Child Sexual Abuse*.

- QCEC liaised through stakeholder groups to plan a colloquium in 2014 to discuss Catholic perspectives in the Australian Curriculum with the intent to inform a broader conference in 2015.
- QCEC received regular reports and recommendations for action on such matters as:
 - *The Royal Commission of Inquiry into Institutional Responses to Child Sexual Abuse*
 - Church responses to *The Royal Commission of Inquiry into Institutional Responses to Child Sexual Abuse* through the Truth Justice and Healing Council
 - Commission of Inquiry into Child Protection in Queensland
 - The annual QCEC Student Protection In-service as a forum for Catholic school authority representatives to be informed and discuss current and emerging student protection issues.

Strategic Objectives

2.4 To work strategically with relevant partners and stakeholders to maximise opportunities

Action

- i) Develop renewed strategic relationships at state level with the Premier, the Minister for Education, the Director-General for Education, the Department of Education, Training and Employment and Education Queensland personnel in the context of the new government and changes to corporate structures.
- ii) Advocacy through national groups/committees as reconvened under NCEC enhanced by appropriate QCEC representation.

Progress

- The advocacy of the QCEC Executive Director and key members of the Commission supported by advice from the QCEC Political Advisory Subcommittee played a pivotal role in forging a sound relationship with the State Government and key government agencies.
- QCEC provided active representation and advocacy nationally through representations to NCEC.

3. Resourcing and stewardship

Strategic Objectives

3.1 To collaborate in the formation and development of a workforce appropriate for Catholic education

Monitor how the outcomes of the CEFARE managed colloquiums have influenced the formation of staff in Catholic schools.

As noted in 2.3, a colloquium for formation of staff in Catholic perspectives is planned for 2014.

3.2 To identify the resourcing needs of stakeholders to facilitate the equitable and just distribution of funds

- i)** Monitor the State Government's action to develop public-private partnerships and the possible implications for the Catholic education sector.
- ii)** Advocacy and strategic advice to NCEC and Queensland based federal parliamentarians with respect to the funding outcomes of the Gonski Review.
- iii)** Receive and act upon recommendations contained in the *Report of the Review of the QCEC Group Funding Arrangements*.

- Liaison with the Department of Education, Training and Employment Infrastructures Services Branch is ongoing.
- QCEC worked to negotiate a Memorandum of Understanding (MOU) for receipt of Australian government funding.
- At its 24 September meeting the Commission voted by majority decision to implement the revised group funding arrangements from 2014.

3.3 To promote and support the sustainability of our resources

Provide strategic advice for QCEC to operate in the most effective and sustainable way including the transition process for all QCEC and QCEC committee meetings to function in a 'paperless' electronic environment.

The majority of QCEC committees, subcommittees and limited-term working groups now meet by videoconference or teleconference, and access meeting agendas and other resources from the members' area of the QCEC secure website.

3.4 To facilitate the provision and integration/embedding Information and Communication Technologies to support the work of Catholic school authorities

- i)** Advocate for affordable access to high-speed broadband particularly for regional Catholic school authorities in the context of Catholic Network Australia (CNA) and the National Broadband Network (NBN).
- ii)** Progress the interoperability agenda in relation to the Queensland Catholic sector initiatives, national initiatives and the Vocational Educational and Training (VET) Unique Student Identifier (USI).

- Piloted online spaces in the CNA portal to support collaboration with some QCEC committees.
- Highlighted broadband challenges for Catholic schools in regional areas in national forums and with governments in the context of CNA and the NBN.
- Proactively engaged in the following national interoperability initiatives:
 - *National Identity Management Framework (NIMF)*
 - *Australian Curriculum Connect (ACC) pilot project*
 - *Education Services Australia (ESA) Identity and Access Management pilot projects*
 - *National Online Assessment Capability (NOAC).*

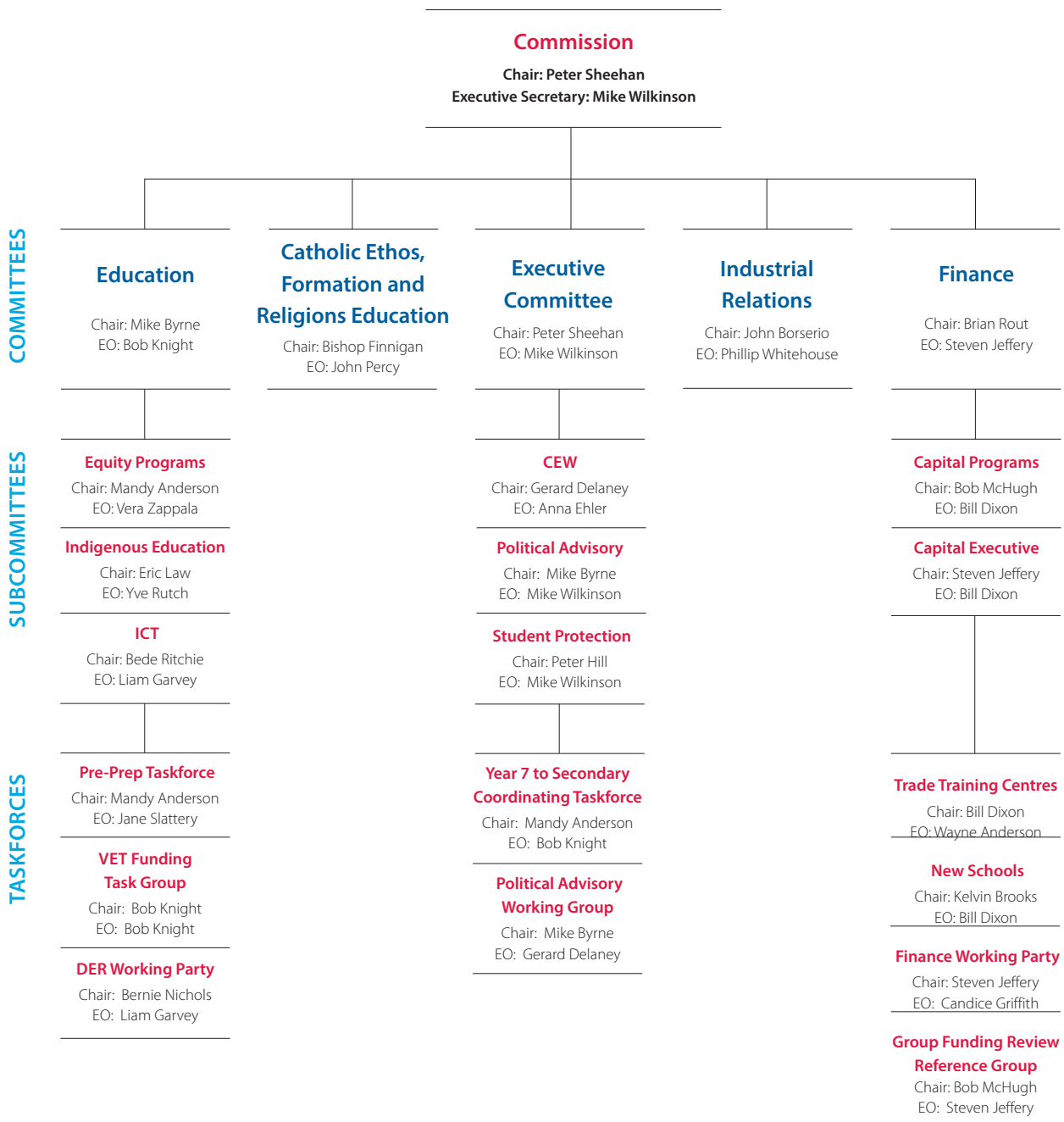
3.5 To resource growth of Catholic schooling into new schools models and new locations

- The Commission approved a QCEC *New Schools Policy*.
- The QCEC New Schools Working Party has been a key source of advice and expertise on the timely provision of new schools.



QCEC COMMITTEE STRUCTURE



EXECUTIVE COMMITTEE

Overview

The QCEC Executive Committee is a six member group derived from the membership of the Commission. It is the only QCEC committee specifically mandated by the Constitution of the Commission.

The Executive Committee is scheduled to meet 11 times a year, usually two weeks prior to a Commission meeting. Its prime responsibility is for advocacy and major administrative decision making without the need for prior direction of the Commission. All decisions of Executive are formally ratified later by the Commission.

Given the scope, weight and urgency of very significant issues coming before the Commission in 2013, the Executive Committee also met three times in extraordinary session and, increasingly, engaged in preparation of issues to facilitate decision-making at QCEC meetings. This included decision-making on critical matters such as revised Australian Government Funding for Schools in Australia, the Review of the QCEC Group Funding Arrangement which is designed to share Government funding equitably across all Catholic school authorities and the Review of QCEC Capital Assistance Programs.

In the latter stages of 2013, the Executive Committee acted as a reference group for a Review of the Efficiency and Effectiveness of the QCEC Secretariat.

The Executive Committee receives advice when necessary from three subcommittees; the Political Advisory Subcommittee, the Student Protection Subcommittee and the Catholic Education Week Subcommittee. The previously established QCEC Year 7 to Secondary Coordinating Taskforce and the QCEC Senior Schooling Taskforce established in November for operation from 2014, also come under the responsibility of the Executive Committee.

All of these groups provide valuable advice to inform the Executive Committee's work on behalf of the Commission. A separate report from the Political Advisory Subcommittee, the Student Protection Subcommittee and the Catholic Education Week Subcommittee can be found on the following pages.

A key feature of 2013 was the federal election and the close collaboration of the Executive Committee with the Political Advisory Subcommittee.

Key Activities of the Year 7 to Secondary Coordinating Taskforce

The role of the Year 7 to Secondary Coordinating Taskforce is to advise and assist with collaboration on matters pertaining to the move of Year 7 to secondary in 2015. Taskforce members work in partnership with the QCEC Secretariat to ensure the move of Year 7 to secondary in 2015 is smooth and efficient.

In 2013, the Year 7 to Secondary Coordinating Taskforce met four times (including one joint meeting with the Pre-prep Taskforce) to discuss and action the following key agenda items:

- Employee Relations issues and the development of common positions and understandings across all school authorities
- Non-Government Schools Transport Assistance Scheme 2015 funding
- parent engagement strategies
- legislative changes and Non-State School Accreditation Board processes
- curriculum and pastoral care planning for students
- models for middle years of schooling
- sharing of initiatives and strategies in the area of staffing
- public relations and communications strategy
- professional learning to support the move of Year 7 to secondary
- use of contingency funding to support the move
- possible research projects.

POLITICAL ADVISORY SUBCOMMITTEE

The Political Advisory Subcommittee (PASC) is responsible for advocacy and negotiation with respect to political issues related to the work of the Commission. The Subcommittee advises QCEC through the Executive Director on matters pertaining to advocacy and negotiation with governments, oppositions and other peak bodies at state and national level.

The membership comprises the six-member QCEC Executive Committee extended by three Bishops' nominees and up to four co-opted members.

For the PASC, 2013 will stand out as a year in which it engaged with significant issues regarding the way both Australian and State Governments engaged with Catholic education and the way in which both levels of government engaged with each other both before and after the federal election on 7 September 2013.

In tendering its advice to the Commission regarding the QCEC position on Australian Government Funding for Schools and rendering support for the QCEC Executive Director in his role as a member of NCEC negotiating key features of the *Australian Education Bill 2012*, the PASC experienced a level of frustration created by the confidentiality demands of the Federal Government in relation to those negotiations.

The State Government publicly expressed similar concerns about this process and the Subcommittee found it difficult to recommend advocacy strategy at state level when the State Government did not have clarity about its funding from the Federal Government and, therefore, was unable to make firm commitments about some aspects of its funding for Catholic education.

A private government relations consultancy firm was engaged and its representative regularly met with the PASC to assist the PASC and QCEC to refine its approach to advocacy with governments with particular relevance to the State Government.

Following the election, there was still considerable scope for advice from the PASC as the new Australian Coalition Government settled into implementing its election commitments in relation to school funding and elements of the *Australian Education Act 2013* which became law in the last days of the Federal Labor Government.



In the transition from 2012 to 2013, the PASC farewelled retiring Brisbane Catholic Education Executive Director David Hutton and welcomed his successor Pam Betts. Bishops' nominee, Ted O'Brien, was also farewelled following his resignation from the PASC due to his endorsement as the LNP candidate for the election in the Federal Electorate of Fisher. The Bishops of Queensland appointed former LNP member for the seat of Toowoomba South in the Legislative Assembly of Queensland and former State Government minister, Mike Horan, as their nominee.

QCEC continues to acknowledge the time and commitment of those voluntary PASC members who do not have the benefit of day-to-day roles in Catholic education, but give of their considerable expertise in the area of political advocacy and government relations.

In 2013, the Subcommittee met eight times and dealt with the following matters:

 - *Australian Education Bill 2012*
 - Senate Committee Inquiry into the *Australian Education Bill 2012*
 - Federal Election 7 September 2013 – Alignment of QCEC advocacy strategy and NCEC advocacy strategy
 - *Great Teachers = Great Results* Initiative
 - Principles relating to policy and funding models which might underpin the Catholic response to the Australian Government announcements on school funding
 - clarification of the confusion in the general community arising from differing messages in the media about Australian Government funding for schools

CATHOLIC EDUCATION WEEK SUBCOMMITTEE

Catholic Education Week was celebrated from 21-27 July 2013 and centred on the theme ***Making a Difference - Inspired by Jesus.***

Catholic education communities across Queensland were invited to celebrate and share how they are 'making a difference' in the lives of their students and within their local communities.

The CEW Subcommittee once again focused primarily on providing impetus and developing resources to support school-based activities to help schools communicate the distinctive mission of Catholic education within their local communities.

In addition, the Subcommittee planned an official launch event at St Mary's College, Ipswich where the week was officially launched by Bishop Joseph Oudeman. A State Government reception hosted by Minister for Education, the Hon John-Paul Langbroek, at Parliament House, and an Edmund Rice Foundation reception were also organised.

A feature of CEW was the annual presentation of the Spirit of Catholic Education Awards to recognise staff members, parents, clergy or volunteers who have made an outstanding contribution to the life of a Catholic school community or Catholic education agency.

Response to the awards was again strong with 78 nominations received from across the State. The following recipients were presented with awards by the Governor of Queensland Ms Penelope Wensley AC as part of the official launch event.

Anthony's work with the Christian Brothers Oceania Province in their mission of reaching out to the poor in countries such as Kenya, Tanzania, Papua New Guinea, East Timor and the Philippines, truly brought to life this year's theme.

Anthony's visits to each of the five Queensland dioceses where he met with various groups of students, staff, parents and parishioners, were very well received.

The Commission was once again grateful to the QT Mutual Bank, Australian Catholic Superannuation and Retirement Fund (ACSRF) and the Australian Catholic University (ACU) for their generous sponsorship of Catholic Education Week.

STUDENT PROTECTION SUBCOMMITTEE

The membership of the Student Protection Subcommittee (SPSC) includes people with unique and diverse expertise who provide advice on which QCEC frequently relies to make decisions regarding the important and sensitive matters involved in ensuring the safety of students in Catholic schools.

Throughout 2013, the SPSC carefully monitored current and emerging issues in the area of student protection including legislation and regulation, resources for educating staff, students and their families and matters arising from a number of inquiries into child protection. Without doubt, the issues considered by the SPSC were more numerous and diverse than at any time in the last decade.

The report of the Queensland Child Protection Commission of Inquiry (Carmody Inquiry) was released late in the year. A number of the recommendations are aimed at significant restructuring of the child protection system in Queensland including the *Working with Children Check* and the *Commission for Children, Young People and Child Guardian*. The SPSC played a significant role in preparing correspondence to the State Government aimed at confirming the commitment of Catholic education to child protection in Queensland while expressing the concerns of Catholic school authorities about some of the recommended changes which could impact negatively on students and families in Catholic schools.

With the establishment of the Royal Commission into Institutional Responses to Child Sexual Abuse, the SPSC maintained a watching brief on the many issues papers released by the Royal Commission and has developed a number of responses on behalf of QCEC. These responses have been provided to the Truth Justice and Healing Council established by the Bishops to coordinate the Church's response to the Royal Commission.

The annual QCEC Student Protection In-service for Catholic School Authorities was held in May and the program included the following sessions:

- *Sexual abuse and likely sexual abuse: What you need to know about child sex offenders and offending behaviour* - Emeritus Professor Freda Briggs AO
- *Sexual abuse and likely sexual abuse: What you need to know about protecting children from offending behaviour and supporting children who have been the targets of offending behaviour* - Emeritus Professor Freda Briggs AO

- *Reporting Sexual Abuse and Likely Sexual Abuse: Making a report and what follows* - Detective Senior Sergeant Jim O'Brien and Detective Sergeant Angela McCarthy (Child Safety Policy and Programs), Child and Sexual Crime Unit, Child Safety and Sexual Crime Group, State Crime Operations Command, Queensland Police Service.
- *The Daniel Morecombe Child Safety Curriculum* - Brett O'Connor, Director, Child Safety, Queensland Department of Education, Training and Employment.
- *Current Requirements for Catholic School Authorities Written Procedures for Student Protection and Related Training Procedures* - Members of the SPSC

For some time, the SPSC has been considering the best way to support Catholic school authorities to develop and maintain written procedures for student protection which is an important criterion for the accreditation of non-state schools. This now takes the form of a *Minimum Standards Document for Student Protection* provided for use within Catholic schools.

The SPSC continues to engage with the matter of students becoming victims of abuse through various forms of social media and the need for 'cybersafety'. Cybersafety Protocols for Escalating Complaints Regarding Offensive Material on Social Media have been negotiated with social media providers. When Catholic school authorities encounter difficulty engaging directly with these providers, the authorities enact the protocols by asking the QCEC Secretariat to deal directly with the providers as an escalation of the complaint to remove certain offensive materials from the social media sites.

Plans for 2014 are already in place. In particular, planning for the 2014 QCEC Student Protection In-service for Catholic School Authorities is well advanced and comprises the following program:

- Ms Megan Mitchell, National Children's Commissioner, will speak about her role of advocating for the rights of children and young people across Australia
- Dr Kathy Albury, Senior Lecturer, Journalism and Media Research Centre, the University of New South Wales will speak on the subject of research she has conducted regarding young people sexting and sexting as a workplace issue

- Ms Claire Pirola, Professional Officer, Catholic Education Office, Sydney will speak about *Responding to student sexualized inappropriate behaviour in schools, lawfully, ethically and successfully. The challenge for leaders in education*
- Mr Francis Sullivan, Chief Executive Officer of the Truth Justice and Healing Council which is coordinating the Catholic Church's response to the Royal Commission into Institutional Responses to Child Sexual Abuse.

CATHOLIC ETHOS, FORMATION AND RELIGIOUS EDUCATION COMMITTEE

Overview

In providing advice to Queensland Catholic Education Commission (QCEC), the Catholic Ethos, Formation and Religious Education (CEFARE) Committee:

- attends to items relating to ethos, formation and religious education referred by the Commission
- monitors the implementation of QCEC policies from the perspectives of Catholic ethos, formation and religious education
- identifies, monitors, discusses and makes recommendations regarding emerging issues and needs in Australia and beyond pertaining to Catholic ethos, formation and religious education and where necessary makes proposals to the Commission for relevant research
- supports and co-ordinates at a provincial level collaboration and action arising from the relevant directions that emerged from the Bishops' Research Project *Catholic Schools for the 21st Century*
- collaborates with, supports, and provides advice to other QCEC committees in all matters pertaining to Catholic ethos, formation and religious education
- considers and responds to State and Commonwealth policies and initiatives from the perspectives of Catholic ethos, formation and religious education, including matters related to the provision of Catholic religious education and chaplaincy in schools outside Catholic schools.

- new curriculum for religion

- Year of Faith.

INDUSTRIAL RELATIONS COMMITTEE

Overview

The Industrial Relations Committee is a forum for Catholic education employing authorities which allows the Commission to fulfil its delegations in the area of industrial relations with respect to facilitating collaboration between employing authorities in Catholic education.

The Committee may also deal with industrial relations issues referred to it by Catholic education employing authorities.

A key focus of the Committee in 2013 was the overview of enterprise bargaining (EB) negotiations for the Diocesan Principals' Agreement. These negotiations commenced in March and settlement was achieved in August.

The negotiated outcomes provide a fair and responsible enhancement to the working conditions of Principals in diocesan schools.

Key Activities

In 2013 the Industrial Relations Committee met five times to discuss and/or develop strategy for the implementation of key agenda items including:

- EB7 Implementation – An essential part of enterprise bargaining involves the implementation of matters negotiated during this process. The following key negotiated outcomes have been, or are in the process of being implemented:
 - Deferred salary scheme – policy guidelines have been developed and distributed to employing authorities
 - Review of school counsellor conditions – research and data gathering has been completed. Working collaboratively with the union to develop a comparative analysis of conditions of work for counsellors in all Queensland Catholic schools.
 - Consolidation of working conditions for boarding house staff and services staff (grounds and maintenance) – separate discussions held with union for these cohorts of employees. In principle agreement reached on non-wage consolidation, however union attempted to negotiate increased wage rates. Both parties agree that no further work can be conducted on this matter until the next round of enterprise bargaining in 2015.
- Middle leadership structure – worked collaboratively with the union to develop a training package and held state-wide workshops for teaching staff in preparation for the implementation of the middle leadership structure in 2015 (replaces PAR).
- Review of Experienced Teacher 6 – action is being undertaken on this project and is expected to be finalised in 2014.
- Social media – draft policy framework has been developed and will be made available to all employing authorities by the end of Term 1 2014.
- Diocesan Principals' EB – over a five month period during 2013, enterprise bargaining negotiations for replacement Agreements in each of the five Queensland dioceses were conducted. These negotiations were conducted in good faith and achieved important wage and non-wage enhancements to the conditions of work for principals. Successful ballots of all diocesan principals were conducted which culminated in the approval by the Fair Work Commission of five separate Agreements covering all diocesan principals. These Agreements have a nominal expiry date of 30 June 2016.
- Transition of Year 7 to Secondary initiative – participation in consultative strategy and overview of industrial relations strategy
- Representation at the National Catholic Education Commission (NCEC) Employment Relations Conference in September
- Preparation of professional development materials covering various topical IR/HR matters and legislative updates including workplace bullying, flexible working arrangements, adverse action, managing underperformance, right of entry, workplace harassment and sexual harassment.

The prime responsibility of the Education Committee is to provide:

- broad educational positions for policy direction statements as requested by QCEC or by way of advice from the committee to QCEC.

- Catholic perspectives in the Australian Curriculum and Indigenous Spirituality
- Australian curriculum development and implementation, including responses to the Queensland Studies Authority (QSA) and Australian Curriculum Assessment and Reporting Authority (ACARA) on curriculum documents, transition issues impacting on schools and implementation timelines
- Data guidelines and protocols
- State government initiatives including *A Fresh Start*, *Great Teachers = Great Results* and *Youth Support Coordinators Initiative*
- Indigenous education funding, initiatives and activities
- Information and communication and technologies including online testing, online curriculum, *Identity and Access management project*, social media and other government initiatives

In 2013, the Finance Committee continued to exercise oversight for all financial aspects of government funded programs and ensure that there is an appropriate framework in place to enable effective accountability and compliance with prescribed requirements. Additionally, the Committee engaged with a number of issues of longer term strategic interest for the Queensland Catholic school sector.

Australian Government Funding

Funding from the Australian Government is the most significant source of income for Queensland Catholic schools, representing on average approximately 60 percent of school recurrent income. In June 2013, the Australian Education Act 2013 was passed by Federal Parliament, significantly altering the way recurrent funding is calculated for all Australian schools.

Under the Act, a base funding amount is determined for each student based on a Schooling Resource Standard (SRS). For non-government schools, this amount is then discounted according to schools' socio-economic status (SES) scores. It has been negotiated with the Australian Government that for Catholic schools the average SES score in each State and Territory will apply. For Queensland Catholic schools, this is SES 101.

Funding in addition to the SRS amount is then provided according to the needs criteria of location, size, socio-economic status, students with disabilities, Indigenous students and students with English as a second language. In the immediate term, these changed funding arrangements are expected to deliver a similar level of Australian Government funding for Queensland Catholic schools as that currently being received.

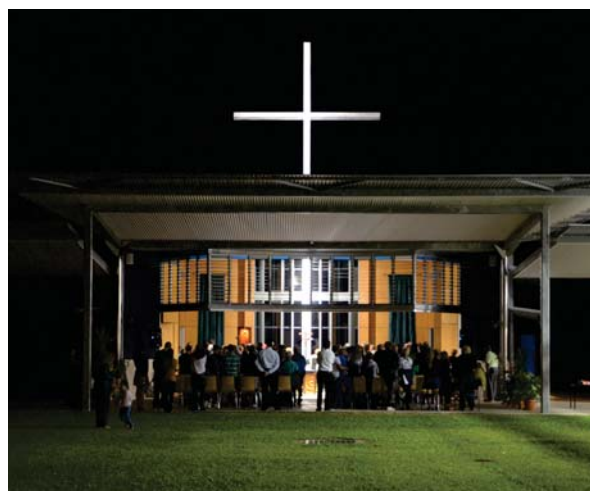
The Finance Committee will continue to monitor and respond to developments in relation to Australian Government funding. It is anticipated that there will be further changes and adjustments as the new funding system is implemented over the next few years.

State Government Funding for Schools

The Queensland Government is an important partner in the funding of Catholic schools. With respect to recurrent funding, the 2013/14 State Budget included a 5.5 percent increase in funding for non-government schools. This increase will result in higher per student funding rates for Catholic schools in 2014.

The Queensland Government also continues to provide significant capital funding to assist with the provision of appropriate infrastructure in schools. This includes funding to support the move of Year 7 to secondary education, the construction of new schools and the refurbishment of existing schools.

QCEC continues to engage and advocate with the State Government to secure funding support for Catholic schools. In this context, the changes to Australian Government funding discussed above have the potential to impact upon State Government funding. As originally envisaged, the new arrangements were to incorporate both Australian and State Government funding into the one national funding system. While funding from both levels of government remains separate at this stage, this may alter in future years.



Group Funding Review

Group Funding is the name given to the funding arrangements by which Australian Government recurrent funds are distributed to Queensland Catholic schools. Prior to each new funding period, the Group Funding methodology is reviewed to ensure that it continues to deliver appropriate funding outcomes.

The current Australian Government funding period concludes at the end of 2013. Particularly in the light of the extensive changes to Australian Government funding for schools outlined above, the Commission established a Group Funding Review Taskforce to advise it on options post-2013.

The Taskforce undertook extensive analysis of school resourcing and funding distribution matters and informed by this work made a series of recommendations as to how Group Funding should be structured from 2014 onwards. These recommendations were endorsed by the Commission in September 2013.

Transition of Year 7 to Secondary

From 2015, Year 7 will be part of secondary education in Queensland and Queensland Catholic schools have undertaken extensive planning and work to ensure the success of this transition.

As well as changes to school operations, an important issue for Catholic secondary schools has been the requirement for additional facilities to accommodate the Year 7 students. Following audits of existing building spaces, a request was made to the State Government for capital assistance for the required construction and refurbishment work. The State Government determined that \$105m in capital assistance would be made available, with no additional funds to assist boarding schools to increase their boarding accommodation for Year 7 students.

Assessments have now been undertaken of all Year 7 capital projects, with funding allocations spread over three application rounds which began in Semester One 2012. These assessments have shown that \$130.5m in total capital assistance is required to support both the construction of general classrooms and the expansion of boarding facilities. These funds have been secured from the Year 7 capital funds provided by the State Government and other existing capital programs, and have been approved by the Commission.



Additionally, the State Government has put in place an exemption for Year 7 building projects from local government infrastructure charges. This exemption is of significant financial assistance to the Catholic school sector.

Other Issues

The Finance Committee has continued to deal with a broad range of financial and compliance issues including:

Not-for-Profit Reforms

In December 2012, the Australian Government established the Australian Charities and Not-For-Profits Commission (ACNC) as a national regulator of charities and not-for-profit organisations, including non-government schools. During 2013, QCEC has coordinated compliance with new ACNC requirements, including a registration process undertaken by schools and school authorities.

QCEC has also been actively engaged in consultation at an Archdiocesan level with regard to reporting and compliance, and via the Australian Catholic Bishops' Conference with respect to the broader not-for-profit legislative and regulatory reform agenda. The latter has included the introduction of a statutory definition of 'charity' and consideration of charitable entities' access to Commonwealth tax concession arrangements.

It is anticipated that there will be further developments in this area in light of the priorities of the Australian Government.

Compliance Requirements

In 2013, QCEC continued to provide information on and coordinate a range of compliance issues impacting on schools. Among the issues were changes to privacy legislation, copyright licences and charges, chemical safety documentation, student transfer note procedures and eligibility of visa subclasses for government funding.

In addition, an extensive array of government data collections were conducted by QCEC including the NAPLAN Student Background Data Collection, Student Attendance Data Collection, Kindergarten Census, Financial Accountability for Government Funded Programs, Indigenous Remote and Boarding Students, State Government Census, Children in the Care of the State, VET in Schools, Queensland College of Teachers Census, Safety in Schools Collection, Australian Government Census, the Financial Questionnaire for Non-Government Schools and English as a Second Language: New Arrivals.

General Oversight

The Finance Committee has a watching brief over all programs of government assistance. In 2013, \$1.42b in payments were made under government programs as set out below in Table 1.

CAPITAL PROGRAMS SUBCOMMITTEE

Overview

The Capital Programs Subcommittee's prime responsibility is to provide advice to the Commission on matters pertaining to capital development and the administration of all aspects of the State and Australian Government capital assistance programs. The Subcommittee operates with advice from several subsidiary working parties.



Key Activities

In 2013, the Capital Subcommittee made funding recommendations under particular programs and provided advice on the administration and delivery of assistance for the following programs:

Australian Government

- Capital Grants Program
- Trade Training Centres

State Government

- Capital Assistance Scheme
- External Infrastructure Subsidy
- Building Our Future Schools Fund
- Flying Start (Year 7 to Secondary)
- Tomorrow's Schools
- Kindergartens

The outcome for the 2013 capital round is summarised in the table below.

55.6% of funding was recommended to fund new schools, and 37.3% of funding was recommended to fund growth in existing schools. This totals 92.9% of the available funds being recommended to fund growth in student numbers across the state.

In November 2012, the Capital Programs Subcommittee review report conducted by Sr Monica Cavanagh and Mr Bill Walsh was presented to the Commission. The Commission continued to oversee the implementation of the review recommendations during 2013.

Also during 2013, the Capital Programs Subcommittee conducted the final round for the move of Year 7 to secondary. Over the three rounds of funding, a total of 84 secondary schools were recommended for \$130.500m of funding for teaching spaces and boarding facilities to be constructed before 2015.

SCHOOL TRANSPORT REFERENCE COMMITTEE

The Non-Government School Transport Assistance Scheme (NGSTAS) is a joint initiative of Independent Schools Queensland (ISQ) and the Queensland Catholic Education Commission (QCEC). This Scheme consists of two programs, the Bus Fare Assistance and Students with Disabilities Programs.

Bus Fare Assistance Program

Parents whose children attend schools outside the Brisbane City Council boundary and meet set criteria are assisted with the cost of fares to and from school for their children under the Bus Fare Assistance component of this Scheme. This assistance has been important for many schools in managing their viability.

Students with Disabilities

Parents whose children are verified with a disability and meet set criteria have been assisted with the cost of transporting their child/children to and from school under the Student with Disabilities component of this scheme.

All applications are received electronically and uploaded into QCEC's data management program following a rigorous checking procedure. Further upgrades to this system are planned for 2014. Payments are made electronically through the Archdiocesan Development Fund. In 2013 over 4,000 students were assisted with bus fares or the cost of transport to and from school.

The significance of this scheme is reflected in the demand from parents for assistance and the continued support received from those schools involved in the Scheme, particularly in the context of the ever increasing cost of school transport.

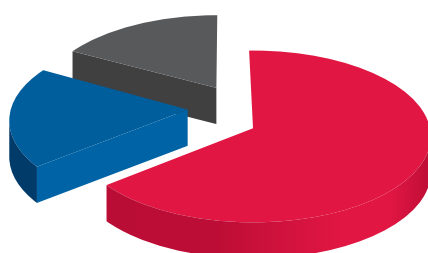

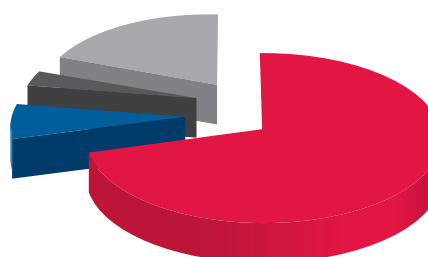

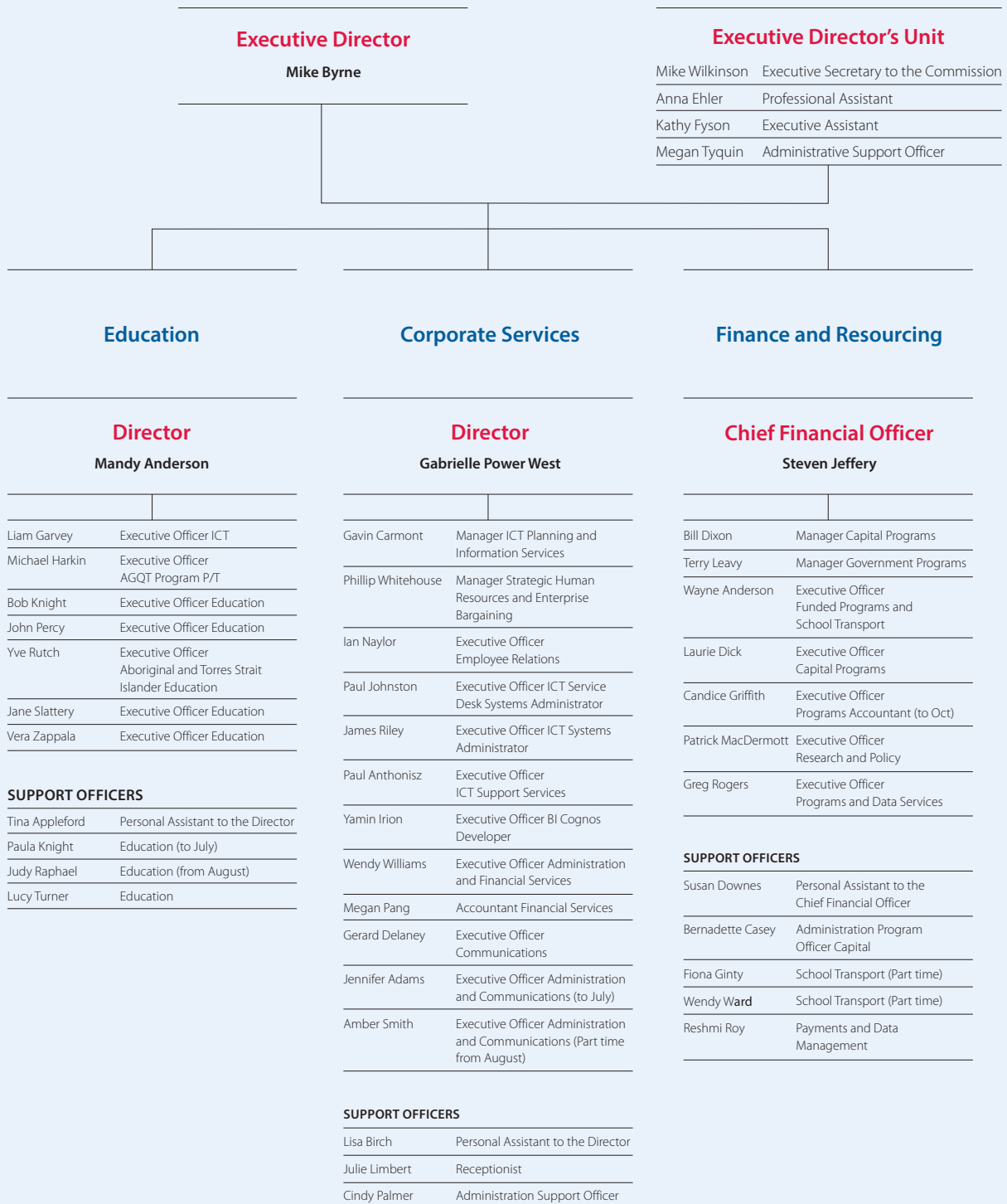
